## 30 years of professional representation

ACFO-ACAF celebrated 30 years of representing public service finance and audit professionals in 2019. Throughout our history, we've established a reputation for professionalism and thoughtfulness. We are firm but fair advocates for our members and a respected voice on key issues, which has resulted in direct benefits for our community, including:


- above-average increases at the bargaining table;
- group-specific wins for FIs including better annual leave provisions and a robust annual training fund jointly managed with the employer; and
- an in-house training and development institute specifically tailored to finance and audit professionals.

We are also active affiliates of the Canadian Labour Congress and Public Services International, which gives us a louder voice and the support of strong allies when we bring issues forward. We regularly appear before parliamentary committees; we've been invited to appear before the UN and the International Labour Organization (ILO); and we are widely known to "punch above our weight" in the workplace and at decision-making tables at every level.

## Direct accountability to our members

ACFO-ACAF prides itself on being a directly democratic union. All members directly elect representatives to the board of directors and, as such, the board is accountable to the membership. Every member is entitled to cast a vote in elections, on our bylaw amendments and on any other resolution brought before membership as part of our Annual General Meeting (AGM). Electronic voting ensures all members can exercise their democratic rights regardless of their ability to attend the AGM.

As ACFO-ACAF members, these rights now extend to you: you will be entitled to vote in all elections, amendments and resolutions at the next AGM. Furthermore, we know how important it is for the audit community to have a strong, dedicated voice in ACFO-ACAF's vision and strategic decisions, so we have ensured representation on our board of directors, with a board seat specifically designated for a member of the CT-EAV Subgroup. This position is being held on an interim basis by **Linda Howes** and will be until an election for the position is held at the next ACFO-ACAF Annual General Meeting. ## Services beyond the norm

#### Labour relations

Unlike most unions, ACFO-ACAF does not rely on stewards for workplace representation. All our members have the right to get one-to-one labour relations support directly from our professional, experienced staff. We're proud of the labour relations service we provide – from answering questions about provisions of your collective agreement to support and representation on even the most complex grievances or complaints. Our Labour Relations Advisors will manage your case from beginning to end, and your conversations and correspondence with them are confidential unless you agree to make them otherwise.

We pride ourselves on our collaborative and professional approach to workplace issues. We're often able to resolve cases without resorting to formal grievances, thus maintaining good relationships for our members in their workplace and resolving cases more quickly. When we do need to move

forward with something more formal, our track record is solid, and our membership satisfaction scores are consistently higher than average.

#### Collective bargaining

ACFO-ACAF also believes in a professional and collaborative approach to collective bargaining. We were among the first groups to pilot interest-based bargaining in the federal public service and we've managed to consistently secure better-than-pattern increases for our members.

Beyond improvements to rates of pay, we have also secured a robust annual training fund and other group-specific benefits for our members that recognize the unique, professional role they play in the workplace.

#### Professional development and more

ACFO-ACAF is much more than a union: we're a professional association too, one that is committed to helping our members progress in their careers. We run our own in-house professional development institute called the Comptrollership Training Centre and provide a career matchmaking service through our CV Inventory and annual Job Fair. Additionally, our flagship Spring Tune Up event attracts world-class speakers like Prime Minister Jean Chrétien, astronaut Chris Hadfield, broadcasting legend Peter Mansbridge, Olympian Clara Hughes, Dragons' Den star Manjit Minhas and more. We're always working to meet and anticipate your needs as finance and audit professionals in the public service.

ACFO-ACAF members also have access to the comprehensive annual State of the Community survey reports. The survey reports allow you to compare work-life balance and other job satisfaction scores for departments across the public service as rated by your fellow ACFO-ACAF members. This can help you to make smarter decisions about your career progression and gives us the ability to advocate for improvements among lower-performing departments.

And of course, ACFO-ACAF members have access to a range of discounts on products and services through membership in the ServicePlus discount program and as part of deals with insurance and professional service providers.
